"I am not an office-bearer of this trust. I corresponded with the state government because the trust is from my area and I wanted that poor kids from my constituency get good education. This land will not be given for free and will not be used for commercial purposes. I thank the government for giving the land to the trust," Selvan told The Indian Express. As per the government resolution dated July 31, 2023, the trust will be paying around Rs 14 crore to the government.

On September 9, 2024 Selvan had raised the demand seeking the land to be given to the said trust as 'special case' for the primary and secondary school meant for EWS and weaker sections. Based on this. Mumbai (City) collector submitted a report on September 11

THE BOMBAY High Court Friday disposed of Zee Entertainment's petition alleging that the Central Board of Film Certification (CBFC) was "illegally" and "arbitrarily" withholding certification for the Kangana Ranaut-starrer Emergency film. The decision taken after Zee Entertainment Enterprises, a coproducer of the film, informed the Bombay High Court that certain changes including cuts suggested by the revising committee of the CBFC were agreed with.

The producers said that, as per the arrangement made between the parties to the case, they will submit the revised master copy of the film within 30 days once such changes are made and the CBFC will verify the same and issue a certificate within 14 days (two weeks) thereafter.

THE MAHARASHTRA cabinet on Friday gave its approval to set up a green integrated data centre park, which is expected to attract an investment of Rs 1.60 lakh

According to a statement issued by the state government, Maharashtra is the first state in the country to come up with a special policy for green integrated data centre park, which will attract multinational and global companies operating in the data centre sector. As a result. significant investments of around USD 20 billion (Rs. 1.60 lakh crore) will help the state to maintain its top position in the data centre sector

"As Green Integrated Data Centre Park is an emerging project, it will directly provide employment to approximately 500 highly-skilled experts and indirectly provide employment to approximately 3,000 people having modern technology qual-

know of the matter. "With the advent of artificial

intelligence (AI), the demand for data storage and processing is increasing manifold. But at the same time, global warming is a major concern due to excessive energy consumption by data centres. As India is taking steps to become a carbon footprintfree country by 2070, it is considering the growing demand for green technology in the future. The green integrated data centre parks will attract multinational companies and help create an enabling ecosystem in India,' said the official.

The Information Technology and Information Technology Support Services Policy 2023 has been partially amended to allow additional incentives for green integrated data centre parks in the state, subject to the terms and conditions of the Cabinet proposal, along with concessions as well as regular incentives.

"Additional incentives have been approved...The eligibility criteria for the said projects are

three green integrated data centre parks have to be proposed with a minimum 500 MW capacity with a fixed capital investment of at least Rs. 30.000 crores. The incentive will be given for 20 years for the said

Eligible new green integrated data centre parks will be given incentives only after meeting fixed capital investment criteria and investing a minimum of Rs 10,000 crore along with their colocation investment. The scheme will automatically terminate after the establishment of the first three green integrated data centre projects in the state..," read the statement issued by the state government. The Maharashtra Cabinet on Friday also gave its approval to implement a policy to encourage more projects by revising the mega project plans based on modern technology.

As part of it, an industrial promotion subsidy will be given to mega projects having an investment worth Rs 10.000 crores established anywhere in the state.
