

Pant, Gill put India in command with emotional hundreds

Rishabh Pant and Shubman Gill cleansed months of hurt, anxiety and disappointments of varying nature with emotional hundreds on the third day to place India in a prime position to win the first Test against Bangladesh here Saturday. Gill (119 not out) and Pant (109 led the hosts' run glut with an alliance of 167 for the fourth wicket that helped India, overnight 81/3, declare their second innings at 287 for 4 for an overall lead of 514. Bangladesh showed some spunk in their second innings to reach 158 for four when play was called off at 4.25 pm due to bad light. They still need a whopping 357 runs for the result to be in their favour. Skipper Najmul Hossain Shanto (51) and Shakib Al-Hasan (5) were manning the crease for the visitors, and the day could have ended on a better note for them have they been a slightly more judicious in shot selection against star off-spinner R Ashwin (3/63). But let's forget the match situation and those dreary numbers for a while to cast a deeper look into the story of the day.



Pant stood near the middle of the pitch with closed eyes, an upward tilted head and a raised bat - offering a silent prayer, perhaps, to the Lord above for returning life and cricket to him. Gill watched the whole scene from a fair distance, as he did not want to invade into an intensely private moment of his partner. Soon, the two brave-hearts melted into a warm embrace

as Chepauk erupted. Perhaps, the moment stood also as a tribute to Pant equalling Chennai's very own 'Thala' MS Dhoni's record for the most Test hundreds by an Indian wicketkeeper-batsman - six. Compared to Pant's, the struggles of Gill have been less pronounced as they were more mental than physical in nature, stemming primarily from the lack of confidence in

himself in the traditional format. However, since making that hundred against England at Visakhapatnam earlier this year, Gill seemed to have turned a corner and he further validated that journey upwards with his fifth Test hundred, fetched through a single off Mehidy Hasan Miraz. But while Gill, beginning from overnight 33, and Pant,

starting from 12, were in the office, all these feelings were hidden as it was time to enjoy the sight of them taking down Bangladesh bowlers in their contrasting methods. The left-hander started rather sedately, looking to get his eye in before opening up. The breakthrough moment came when Pant pulled off-spinner Miraz for a four around the first drinks break of the day. Since that point, Pant's

dismantling of Miraz became a feature of the innings as he brought up his fifty off 88 balls. Once the fifty was achieved, the 26-year-old unfurled some of those typical Pant shots. Pant moved around the crease like a trapeze artist, and his scooped six over fine leg off Hasan Mahmud enthralled a sizeable weekend crowd here. He was dropped on 72 by Shanto off Shakib but that was not even a deterrent. He duly completed his ton before offering a return catch to the hard-working Mehidy. Minimalism is quintessential to Gill's batting as he plays shots with little flourish. The short-arm pull from in front of the face or that zero follow-through punch through the covers, which he often executed off pacers Nahid Rana and Hasan, might not be out of the batting manual but were productive nonetheless. Gill milked a further 53 runs off 51 balls with KL Rahul for the fifth wicket to take India's lead past 500. However, Bangladesh, tasked with a tall chase, showed better application than in their first innings. Shanto took it upon himself to lead their fightback. But his colleagues, particularly the set Zakir Hasan (33) and Shadman Islam (35), threw their wickets away with callous shots. Shanto, though, was not flustered and creamed Ashwin for three sixes, and the swept one among them earned him fifty off 56 balls as the final passage was played under floodlights because of poor light.



Gurbaz and Rashid lead Afghanistan to first ODI series win over South Africa

Afghanistan won a one-day international series against South Africa for the first time on Friday with a game to spare. The thumping 177-run victory - Afghanistan's biggest in ODIs by runs - came just two days after Afghanistan beat South Africa for the first time. Also, Rahmanullah Gurbaz's 105 made him the first Afghan man to hit seven ODI hundreds. Their strong total of 311-4 in sweltering heat was followed by South Africa being all out for 134 in the 35th over. Leg-spinner Rashid Khan, who injured his hamstring while batting, celebrated his 26th birthday with 5-19 and left-arm spinner Nangeyalia Kharoti claimed 4-26. Afghanistan will eye a series sweep in the final ODI on Sunday. "I had a hamstring (injury), but I tried my best to stay on the ground and do my best for the team," Rashid said. "It was a great opportunity for us to win the series against a big team ... I really enjoy youngsters like Kharoti and (Allah) Ghazanfar, we share ideas with them. It was great to see youngsters coming up and showcasing talent on the big stage against South

Africa." Gurbaz and then Azmatullah Omarzai laid the foundation for Afghanistan's first 300-plus score against South Africa in an ODI. Gurbaz and Rahmat Shah combined for a 101-run for the second wicket. The 90s brought some nervy moments for Gurbaz. On 99, he played a maiden over from Bjorn Fortuin then swept Aiden Markram to square leg. He celebrated his century by making a heart shape with his hands and blew a kiss to his teammates in the dressing room. Nandre Burger made the breakthrough when he bowled Gurbaz for 105 off 110 balls, including 10 boundaries and three sixes. But Gurbaz's exit brought on Omarzai. He hit an unbeaten 86 off 50 balls, while Shah added 50 off 66. Omarzai smashed six sixes and five fours as Afghanistan scored 93 runs in the last 10 overs. "Congrats to our nation," captain Hashmatullah Shahidi said. "We're happy here and all people back home will be happy. In the batting, the way Gurbaz started and then Rahmat and Omarzai carried on, all of them were very good. When it comes to bowling, I know the spinners will deliver it for me."

Harmanpreet nominated for FIH Player of the Year

Skipper Harmanpreet Singh, who powered India to a second successive bronze medal in hockey at the Olympics in Paris, was on Saturday nominated for the FIH Player of the Year Award. The 28-year-old ace drag-flicker, who was the top scorer at the Paris Olympics with 10 goals from eight matches, had previously won the award twice in a row from 2020-22. "It is a great honour to be nominated for the FIH Player of the Year Award again," the Indian defender stated in a Hockey India release. "While I am elated to be named among some of the best players in the world, I would like to acknowledge that it would not have been possible

without the support of my team. "All the goals I have scored in the FIH Hockey Pro League, and the Paris 2024 Olympic Games are because the team created those goal-scoring chances for me," he added. Harmanpreet has been nominated along with the Dutch duo of Thierry Brinkman and Joep de Mol, Hannes Müller of Germany and Zach Wallace of England. All international matches held in 2024, including Test matches, the FIH Hockey Pro League, FIH Hockey Nations Cups, FIH Hockey Olympic Qualifiers and the Olympic Games were taken into consideration. The calm and composed India captain scored seven of his 10 goals through penalty



corners while the remaining three goals were penalty strokes. Harmanpreet described the Paris Olympics as the pinnacle of his career, expressing gratitude to his team for its unwavering support during challenging

times, including his struggles with penalty corners in the previous World Cup. "The Olympic Games in Paris was not just the highlight of my whole career so far. The team has always had my back, especially during the World Cup last year where I couldn't get a goal from penalty corners. "But the team didn't let me wallow or blame myself in any way and while there were a lot of reasons to perform at the Olympics and come back with a medal, I always had it in the back of my head that I needed to repay the faith the team has placed in me," he revealed. Following a short breather after the Olympic Games, Harmanpreet led India's title defence at the Hero Asian

Champions Trophy 2024 in Moqi, China. Leading the team by example again, he scored seven goals in as many games and was named Player of the Tournament. At the end of the tournament, Harmanpreet stood at the pinnacle of the sport having amassed a staggering 205 goals in 226 matches for the country, a feat only achieved by legends of the sport, Major Dhyani Chand and Balbir Singh Sr. "The aim is to bring back the glory days of old. We will leave no stone unturned in order to realise this dream but we cannot do it on our own; we need support from our fans," he said. "As the team prepares for the next Olympics cycle, I urge

Indians to watch the sport and support us," he added.



Bhui inches towards hundred, Iyer scores fifty to consolidate vs India B

Ricky Bhui was 10 runs short of his second successive hundred as India D's overall lead swelled to 311 against India B, when stumps were drawn on the third day of the Duleep Trophy encounter here on Saturday. Shreyas Iyer also showed some form with a purposeful half-century for India D, scoring 50 off 40 balls. At stumps, India D scored 244 for 5 in their second innings with Bhui unbeaten on 90 off just 87 balls with 10 fours and three sixes to his credit. Earlier, India B were all out for 282 in their first innings in reply to D's first essay of 349. Starting the day at 210 for 6, Washington Sundar (87) ran out of partners as none of the tail-enders stayed long enough to give him an opportunity to complete his hundred. Washington's 140-ball knock was studded with the seven fours and a six. Left-arm spinner Saurabh

Kumar, who has been on the fringes for a long time finished with 5 for 73 while Arshdeep Singh couldn't add to his overnight tally of three victims. In the second innings, India D had quickly slumped to 18 for 3 by the start of the fourth over but Iyer and Bhui counter-attacked with great disdain, adding 75 runs in just 10.3 overs. Iyer was finally holed out by Mohit Avasthi off Mukesh Kumar, who took three wickets despite going for 80 runs in his 13 overs. He hit seven fours and a six. Bhui carried on from where Iyer left as found an able ally in Sanju Samson (45 off 53 balls), adding another 68 runs for the fifth wicket in 17.1 overs. Samson also hit a couple of maximums apart from his five hits to the fence. Bhui was at his offensive best when he was joined by young Assam all-rounder Akash Sengupta (28 batting) as they added another 83 for the unbroken sixth wicket in under 13 overs.

Ronaldo helps Al-Nassr win in new coach Pioli's first game

Cristiano Ronaldo opened the scoring as Al-Nassr defeated Ettifaq 3-0 and gave Stefano Pioli victory in his first game as coach of the Saudi Arabian club on Friday. The Italian, who led AC Milan to the Serie A title in 2022, was appointed on Wednesday to

succeed Luis Castro. The Portuguese coach was dismissed the previous day due to Al-Nassr's slow start to the season with just one win in three Saudi Pro League games. Ronaldo, who missed Al-Nassr's 1-1 draw in the AFC Champions League Elite with Al-Shorta of Iraq on Monday due to a viral infection, fired

home from the penalty spot after 33 minutes for his third goal of the season. In the second half, Salem Al-Najdi and Anderson Talisca added to the scoreline. The defeat was the first this season for Ettifaq but the team coached by Steven Gerrard stayed third. Al-Nassr moved to fourth.
