

Congress leaders launch campaign against bureaucrats in MP

Changing tactics, the Congress party in Madhya Pradesh has launched a campaign against bureaucrats in the state after all other attempts failed to corner the Mohan Yadav government. Questioning the neutrality of officials, the Congress is accusing them of following the Bharatiya Janata Party (BJP) and the Rashtriya Swayamsevak Sangh (RSS) ideologies in their functioning. During the last few days, former Chief Minister Digvijay Singh, PCC chief Jitu Patwari, and Leader of Opposition in the State Assembly Umang Singh have issued statements accusing officials in the state of partisan behavior.

The concerted Congress attack has been especially targeted at district collectors and the police administration in the state. Singhar, addressing a gathering at Alirajpur on Friday, minced no words in his criticism of District Abhay Arvind Bedekar. He advised officials to openly take up the flags of the BJP and RSS, and suggested that they should attend shakhas of the Sangh. "You are not needed as Collector here. You will have to work for the public," he warned. Singhar's video, doing rounds on social media, has yet to elicit a response from the state government or any of the officers' associations. Singhar's attack on the official comes close on the heels of a similar outburst by former Chief Minister and Raja

Sabha MP Digvijay Singh. Taking to X (Twitter), Singh accused the Rajgarh police administration of using a traditional regional convention as an opportunity to extract money. Singh, while condemning the tradition, said the Rajgarh Superintendent of Police should have done more than just take the accused to a temple and make them seek penance. The accused was attempting to auction his daughter-in-law as part of the Natrajagda. Singh has been a vociferous critic of the ritual, which takes place in the Rajgarh district of the state. "This tradition is a means of earning for the Rajgarh police," alleged Singh. Following Singh's post, an FIR was registered by the police.

Besides, leading the farmers' agitation at Susner, PCC chief Jitu Patwari alleged that all officials are posted in the field and districts with corruption. He demanded the narco test of 20 select officials to uncover the reality of transfers and postings in Madhya Pradesh. Responding to his allegations, the Indian Administrative Services (IAS) Officers' Association stated that the allegations are baseless and that the officials are discharging their duties earnestly. Last month, when a burglary was reported at the residence of Congress MLA Jaivardhan Singh, his father Digvijay Singh attacked the whole police administration, saying the police are not active as the officers get their postings in police sta-

tions as part of an auction. He posted his allegation on X (Twitter), but instead of getting replies from the ruling BJP or the state government, Bhopal Police Commissioner Harinarayan Chari Mishra replied to the post and maintained that the allegations were baseless and malicious. This is the first time that the police officers and IAS Association have responded to allegations made by opposition leaders in the state. With the state government refraining from responding to the allegations and Congress leaders continuing to throw accusations at administrative officers, it will be interesting to see if the opposition party finally manages to score the brownie points it is seeking so desperately.

Most of the places witnessed drizzles

Bhopal: With few regions receiving good rainfall most of the places across the state witnessed drizzle. Damoh received 20 mm i.e., 45 inches of rain in 9 hours. Bhopal received drizzle during the day. Narmadapuram also received light rain. On the other hand, the day temperature also increased. The mercury was recorded at 35.8 degrees Celsius in Khajuraho. With the rain in Damoh, the day temperature reached 34.2 degrees Celsius. Bhopal recorded 34.8 degree Celsius. Similarly, the mercury was recorded above 34 degrees in Mandla, Narsinghpur, Nowgong, Rewa, Satna, Umaria, Guna, Gwalior, Narmadapuram, Ratlam, Ujjain. Monsoon will lash the state

once again before its departure. Another round of good spell of rain will start in the state from September 24. Due to which the eastern part i.e., Jabalpur, Shahdol, Rewa and Sagar divisions will get good rainfall. The western part i.e., Bhopal, Indore, Ujjain, Narmadapuram, Gwalior-Chambal division will also receive light rain. Meteorologist said, a system is over Gujarat and Rajasthan, but it is not strong. Due to this, there will be no rain. Light rain and thundershowers will continue in some districts. A new system is becoming active from September 24. After this, there can be a rainy season in the state once again. Out of more than 250 dams in the state, about 200 are full. Many gates have been opened 8 to 10 times.

Housing policy gaps engineer unauthorized colonies

Like it or not, unauthorized colonies are an urban reality that cannot be wished away. Besides providing viable housing for the poor, these settlements ensure that the wheels of the city are in constant motion. It takes all kinds of people to run a city. Sanitation workers, hawkers, small businessmen, health services, and transport staff are just as important to the functioning of a city as doctors, professors, and engineers. It is unrealistic to imagine a city without these workers, many of whom come from smaller towns and villages in pursuit of an urban dream. It's a different story that the city often exploits them and turns them into cogs in the giant wheels that our urban centers resemble today. These unrecognized, faceless workers ensure the smooth functioning of the city while providing critical services for paltry sums they earn as wages. It is unfair to extract services from this workforce and treat its presence as a blemish on the

urban aesthetic at the same time. Like it or not, this workforce too has needs and aspirations—needs that are often left unattended by urban planners, and aspirations that are rarely fulfilled by the powers that be. It is only natural for this fairly large chunk of the urban population to look elsewhere for fulfillment. The desire often leads them to developers, builders, and colonizers who cater to this end of the market. The result is shanties and unauthorized colonies, where slum lords and developers deftly place themselves in the gap between the aspirations of the workforce and government housing policy. Recently, the state government spoke of a quarterly revision of land value. The step will definitely curb involvement of the parallel economy in real estate, and thus add to tax revenues, but it will also push urban housing out of the reach of most people, especially the working class. In a nutshell, the move will only inflate the number of people looking for affordable housing alternatives. Little wonder then that unauthorized colonies are

springing up by the day despite the city administration's resolve to act against them. Unauthorized colonies have existed since the very inception of urban centers, often coming up on the edges of the city. These developments slowly integrate into the formal urban fabric. Governments and administrations worldwide have developed programs and policies to foster the merging of these settlements while planning urban expansions. Besides providing affordable, inclusive housing, unauthorized colonies also bring prosperity to residents as they sell at a profit when the city decides to integrate them into the larger urban landscape. By bringing in more players to the real estate game, they also keep the real estate markets from stagnating and prevent the sector from being monopolized by big-ticket developers. At a time when the city administration is digging up roads and destroying infrastructure in unauthorized settlements, one cannot help but wonder if the city can provide affordable housing to its residents or if it even has a coherent policy for the purpose.

Budhni SDM accused of misconduct with saffron organisation at Rehti

Members of a Hindu nationalist organization and local residents on Saturday accused Budhni SDM Radheshyam Baghel of misbehaving with them when they attempted to present a memorandum in connection with a case of alleged 'Love Jihad'. Baghel allegedly behaved inappropriately with Jugal Kishor Sisodia, a prominent RSS functionary, when the latter led a group of people attempting to present the memorandum. A video of Baghel's misconduct, reportedly circulating on social media, has resulted in significant backlash for the official, who is accused of using derogatory language against Sisodia. Following the incident, residents of Rehti and Chakladi expressed their anger. They gathered in Rehti to protest. A memorandum seeking the immediate suspension of Baghel was also submitted to Tehsildar Bhupendra Kaushik and police officer Rajesh Kahare. Among those present were BJP leader and minister of state with cabi-

net rank Manohar Lal Maheshwari, along with office bearers from Hindu nationalist organizations and a large number of residents from Rehti and the Chakladi-Rampur area. In his comments, Sisodia said that a significant number of villagers went to meet Baghel to demand strict action against the accused in the harassment case. He noted that while he was standing back to avoid the camera, the SDM began shouting at him and insisted he come forward to speak. Upset by this treatment, the crowd decided to submit a memorandum to the collector, demanding action against Baghel. In his response, Baghel admitted that there have been some incidents in Chakladi, which led to around two hundred people coming to Rehti to present their concerns. He mentioned that he was listening to them when a person started talking about encroachments from the back. He said that he asked the person to come forward, as this is standard administrative procedure, but denied any intent to offend anyone.

ECI capable of conducting simultaneous elections: OP Rawat

Bhopal: Discussing "One Nation, One Election" in the state capital, former Chief Election Commissioner OP Rawat on Saturday said that the move is only possible after amendments to the Constitution and the Representation of the People Act. Former Chief Election Commissioner and senior IAS officer OP Rawat made the observations while presiding over a discussion on the topic at the Madhya Pradesh Academy of Administration.

The discussion, organized by the Madhya Pradesh and Chhattisgarh Regional Branch of the Indian Institute of Public Administration, was introduced by KK Sethi, chairperson of the IIPA. Explaining various aspects of the concept of simultaneous elections for the Parliament and all state assemblies in the country, Rawat asserted that the Election Commission is capable of conducting such an exercise but noted that electronic voting machines (EVMs) and voter ver-

ifiable paper audit trails (VVPATs) would need to be supplemented. He said that he remembered the government had sought the opinion of the Election Commission on the matter in 2015. The government had also asked for steps that would be a prerequisite for the simultaneous elections. At that time, the Election Commission informed the government that it was indeed possible to conduct both elections together, provided the government undertook four tasks.

First, amendments to five articles of the Constitution would be essential, particularly concerning the terms of the assemblies and provisions for President's Rule. Additionally, the Election Commission indicated that changes to the Representation of the People Act and the rules governing the introduction of no-confidence motions would be required. Specifically, a "constructive no-confidence motion" would need to be instituted, which would not only express a lack of confidence in the current gov-

ernment but also propose a new government that the Assembly could trust, ensuring that the new government could continue for a full five-year term after the fall of the previous one. Senior journalist and political analyst Sarman Nagele mentioned that the 18,626-page report prepared over 191 days indicated that 47 political parties shared their views, with 32 supporting simultaneous elections and 15 opposing it. In India, elections are held for 4,120 MLAs in state assemblies and 543 MPs in the Lok Sabha.
