The militants then entered the hotel, firing indiscriminately. CRPF troops soon arrived and cordoned off the building. One militant attempted to flee but was neutralized by CRPF troops. Later that morning, the second militant also tried to escape. Constable Jitender Singh, with extraordinary courage, pursued him despite his injuries. He continued to fight until the second militant was neutralized as well. Constable Jitender Singh later succumbed to his injuries and was posthumously awarded the President's Police Medal for Gallantry for his unwavering commitment and bravery under duress



In cases of arrivals from third countries or travellers holding visas other than Mexican visas. they are subject to even stricter scrutiny by the immigration authorities, and instances of detention/deportation are much higher, the advisory had clari-

The location where the incident occurred is a common route for migrants. Tapachula, by the Guatemalan border, is an entry point into Mexico for many migrants making the journey towards the US. Both Mexico and the US have begun imposing stricter immigration controls in response to growing migration.

In fact, Mexico's new President Claudia Sheinbaum took oath on Tuesday itself, which was attended by India's Minister of State for External Affairs, Pabitra Margherita. In response to the incident, the Mexican officials have relieved two soldiers of their duties
