SEBI/HO/CFD/PoD-2/PI/CIR/2023/167 dated October 07, 2023 issued by Securities and Exchange Board of India ("SEBI") read together with other previous circulars issued by SEBI in this regard (collectively to be referred to as "SEBI Circulars"), companies are permitted to convene the AGM through VC/OAVM, without the physical presence of the Members at a common venue till September 30, 2024. Accordingly, the AGM of the Company is being held through VC/OAVM.

Further, SEBI vide circular dated January 25, 2022 has mandated the listed entities to issue securities in demat only.

The Company has engaged the services of NSDL as agency for providing e-voting facility (remote e-voting and e-voting during the AGM) to the Members to exercise their right to vote on the resolution proposed to be passed at the AGM.
